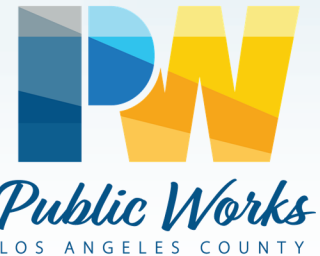
This summer we will be conducting annual hangar inspections. Be sure to look out for the hangar inspection notice arriving at your mail box or inbox with details on when to expect your inspection. Please be prepared with current aircraft insurance, aircraft registration, and current renters/liability insurance for the contents of your unit.

Clear skies brings more airport activity and potential FOD (foreign object debris) that can be hazardous to aircraft. Please be mindful of the limited space when dumping items into the airport dumpsters and refrain from leaving oversized non-airport related items on the ramp.

Also, due to our limited helicopter operating area it is imperative that all rolling pads be removed from transient when helicopter is in flight to allow others to operate in a safe environment. If you see anything that is unsafe or causes a security concern please report it.

Lastly, we are working with DWP (Department of Water and Power) on scheduling LED conversion installations on all of our county-owned and operated hangars in the coming months. We count on your cooperation to make this project move smoothly and provide better airport lighting throughout as well as help lower our energy consumption.

UL94 Unleaded Avgas Available Now

Swift's UL94 unleaded aviation gasoline is now available for sale at Whiteman Airport. Fueling services for UL94 are available on Monday through Sunday, from 6 a.m. to 10:45 p.m.

In order to purchase UL94 for your aircraft, you will need to obtain a Supplemental Type Certificate (STC) for your aircraft and have the STC placard properly displayed on your aircraft. UL94 will only be dispensed into properly certified aircraft. It will not be dispensed into containers or other vehicles and equipment.

Hangar Inspection and Insurance Requirements

The hangar inspection program is intended to verify that hangars that are rented for aircraft storage are used for that purpose and to ensure the safety of all airport tenants. Aircraft must be airworthy with a current annual inspection or there must be a plan in place to bring the aircraft airworthy within a reasonable period of time.

Storage of hazardous materials is not permitted, as outlined in the lease agreements. Fire extinguishers must be certified and easily accessible. Hangar electrical systems should not be modified and electrical devices should be unplugged when not in use.

Finally, proof of proper general liability, automobile liability, and property insurance must be provided annually by all aeronautical and non-aeronautical storage tenants in accordance with the terms of your lease. If you have any difficulty securing the necessary insurance, please contact our office for assistance. We are committed to working with you for the protection of all tenants.
