The Return of the Air Rally at WHP. On October 14th in conjunction with the Whiteman Airport Association and EAA Chapter 40, we will be hosting an Air Rally competition here at WHP. The route which will begin and end here at WHP will be less than 200NM with trophies going to the top 3 crews. The rules are very simple; the crew which completes the course and performs the closest to what is declared is the winner. You can enter in two of the four classes of competition; either digital or analog for navigation and either digital or analog for fuel burn computations. Penalty points are significantly higher for those who use GPS or fuel totalizers vs. those who fly with a chart in their lap. Predict speed, fuel burn, prove (by answering questions) you got to a checkpoint, and the winner is whoever completes the tasks with the fewest penalty points!

Checkpoint latitudes and longitudes, along with checkpoint questions, will be handed out at Whiteman beginning at 9:30 a.m. on the 14th. Then turn in your declarations before a pilot briefing at 11:30 a.m., receive a starting assignment, and start flying at 12:30 p.m..

American Heroes Air Show at Hansen Dam. The annual American Heroes Air Show will take place at the Hansen Dam Recreation and Sports Complex on Saturday, November 4th from 9 am until 4 pm. Parking and admission are free and we'll also be there hosting a tent representing the Airport. The event features a diverse collection of helicopters on static display as well as flying demonstrations. Helicopters from local, county, state and federal agencies will be on display plus displays of specialized rescue vehicles and tactics, technical rope rescues and safety demonstrations. Several helicopters will be operating in and around the dam so please keep that in mind for that day as operations in the air will be even busier than normal.

New certification rule for GA now in effect

On Aug. 30, 2017, the final rule overhauling airworthiness standards for general aviation airplanes officially went into effect.

The FAA expects the rule — which was published in December 2016 — will enable faster installation of innovative, safety-enhancing technologies into small airplanes, while reducing costs for the aviation industry.

“With these performance-based standards, the FAA delivers on its promise to implement forward-looking, flexible rules that encourage innovation,” FAA officials said in a prepared release. “Specifically, the new Part 23 revolutionizes standards for airplanes weighing 19,000 pounds or less and with 19 or fewer passenger seats by replacing prescriptive requirements with performance-based standards coupled with consensus-based compliance methods for specific designs and technologies. The rule also adds new certification standards to address GA loss of control accidents and in-flight icing conditions.”

According to agency officials, the new approach recognizes “there is more than one way to deliver on safety.”

“It offers a way for industry and the FAA to collaborate on new technologies and to keep pace with evolving aviation designs and concepts,” officials said.

The new rule also responds to Congressional mandates that direct the FAA to streamline approval of safety advancements for GA airplanes.

It also addresses recommendations from the FAA’s 2013 Part 23 Reorganization Aviation Rulemaking Committee, which suggested a more streamlined approval process for safety equipment on those airplanes.

The new Part 23 also promotes regulatory harmonization among the FAA’s foreign partners, including the European Aviation Safety Agency, Transport Canada Civil Aviation, and Brazil’s National Civil Aviation Authority.

“Harmonization may help minimize certification costs for airplane and engine manufacturers, and operators of affected equipment, who want to certify their products for the global market,” officials noted.

The transformation “improves the efficiency and effectiveness of the Aircraft Certification Safety System by focusing FAA resources on up-front planning, the use of performance based standards, and a robust risk-based systems oversight program, while leveraging industry’s responsibility to comply with regulations,” FAA officials concluded.
