Spotlight on...

2014 was a great year for the County of Los Angeles airport system. We had a number of significant accomplishments that I would like to share with you and also give you a roadmap for where we are headed in 2015.

Over the past year, we invested nearly \$10 million in capital improvement projects, new facilities, equipment, engineering design, planning studies, and smaller scale maintenance and improvement projects across the County airports. Projects include construction of three new helicopter parking pads and new beacon tower at Brackett Field Airport, replacement of perimeter fencing and gate access control systems at Fox Airfield and Whiteman Airports, design of pavement reconstruction for nearly all of the aircraft parking ramps and aprons at San Gabriel Valley Airport, design of the exit taxiway for runway 06 at Fox Airfield, and design for the south runway and taxiway reconstruction at Compton/Woodley Airport.

Additional funding for capital and other projects comes from the County's Aviation Enterprise Fund, which is really just airport revenue that we put right back into airport improvements. Put in another way,

the money that is generated from hangar rents, commercial leaseholds, fuel flowage fees, etc. is all the money we are able to use to maintain the airports day in and day out. Some of the improvements that were funded exclusively with enterprise funds this year were construction of terminal entry rehabilitation and accessibility ramps at Fox Airfield; replacement of the beacon tower at Brackett Field Airport; two new first response vehicles; and other large and smaller scale maintenance projects. Enterprise funds also provided the means to complete one of our most exciting projects in years:

We recently acquired a portion of a master development at Whiteman Airport that will serve, among other purposes, as the airport's new terminal building. The recently acquired facility will soon undergo minor reconstruction of the second floor to accommodate airport administration offices, a café/restaurant, and a conference room. The first floor already offers a lounge area, flight planning resources, and public restrooms. Additionally, a new vehicle parking lot is being designed to accommodate over sixty vehicles, and it will be constructed directly across the street from the new facility. It is anticipated that, within the next 4 to 6 months, the improvements to the new facility will be complete

and it will be officially open for business. Long-time aviation businesses, Vista Aviation, and Vista Air moved into the facility after it was constructed 5 years ago. They will remain in the building and hangars as welcomed neighbors and new County tenants providing invaluable pilot and aircraft services. The project total was just under \$4 million, but it saved us more than \$12 million and many years of construction of other enabling projects to get us where we are today. Another great benefit of this project is that it enables us to considerably expedite projects related to airfield safety and operational efficiency that could not occur until a new location for the terminal was found.

2014 was a year of change for the County airport system as well. El Monte Airport has a new name: San Gabriel Valley Airport, which was an effort geared toward marketing the airport to the broader region. We stopped watering our lawns and began focusing on sustainable landscape management plans. General William J. Fox Airfield held the inaugural "Los Angeles County Air Show" that boasted an appearance by the Blue Angels as the headlining act and 103,000 attendees! The Los Angeles County Aviation Commission saw two of its members retired: Commissioners Bobby Chase and Aron Wolf of

San Gabriel Valley and Whiteman Airports, respectively. Bobby and Aron brought a depth of knowledge to the Commission that was relied upon to provide guidance on aviation-related issues affecting all of Southern California. We lost a few friends this year as well, including former County Aviation Division Chief Jack Tippee. Thank you Jack for all you did for this amazing system of airports that we all enjoy a little more because of your invaluable work.

2015 is shaping up to be a very busy and productive year already. We have a commitment from the Federal Aviation Administration to fund two projects at a cost of \$5 million, which includes Phase 1 of the apron pavement reconstruction project at San Gabriel Valley Airport and the exit taxiway for runway 06 at Fox Airfield. Other projects to look forward to next year are a new monument sign and landscaping improvements at San Gabriel Valley Airport, generator replacement at Fox Airfield, and the wash rack restroom replacement at Brackett Field. And do not forget to mark your calendars for the 2nd Los Angeles County Air Show at Fox Airfield featuring the USAF Thunderbirds, on March 21 and 22, 2015.

Thanks for another great year from all of us at the Public Works Aviation Division!
